## **Organizational Context & Project Description**

The Office of the UNHCR was established on 14 December 1950 by the UN General Assembly. The agency is mandated to lead and co-ordinate international action to protect refugees and resolve refugee problems worldwide. Its primary purpose is to safeguard the rights and well-being of refugees. It strives to ensure that everyone can exercise the right to seek asylum and find safe refuge in another State, with the option to return home voluntarily, integrate locally or to resettle in a third country (www.unhcr.org).

The agency is mandated to lead and co-ordinate international action to protect refugees and resolve refugee problems worldwide. Guinea-Bissau is a country located on the West Coast of Africa (between Senegal and the Republic of Guinea-Conakry). Member of ECOWAS and other international organizations. It has signed, ratified and is engaged in the implementation of legal, institutional and programmatic instruments for the protection of the human person. In this particular case, the present Government is deeply engaged in the implementation of series of UN and OAU Conventions on durable solutions for refugees, stateless persons, immigrants, internally displaced persons, smugglers, trafficking in persons, protection of women and children in the domestic sphere, work and politics, aamong other engagements. Guinea Bissau presently hosts about 10,000 Senegalese refugees, arriving from the Ziguinchor and Kolda (former Casamance region)/Senegal. The refugees fled from the conflict between Senegalese army and the MFDC. This refugee population is considered as protracted cases since the majority has been in Guinea Bissau for more than 15 or 20 years, living among the hosting communities scattered in over 50 villages across Cacheu region situated 110 km from Bissau. The Office's activities in Guinea-Bissau are committed to the promotion of a favourable protection environment. In order to ensure sustainability and to create a positive environment for local integration, the Office works to empower the existing national structures, the National Commission for Refugees and Internal Displaced (CNRD), through capacity building activities and provision of technical support to the government and other stakeholders. UNHCR is continuously advocating for the access of POC to national services while supporting livelihoods projects to promote refugee's self-reliance. The strategy is to develop a local integration package focused on the naturalization of refugees willing to acquire the Guinean nationality through naturalization process. UNHCR also assists rural refugees and host communities in access to drinkable water, health, education, agriculture and income generating activities as well as urban refugees in education, etc. In order to promote social cohesion between locals and refugees, the Office supports the existing services and the Government's strategy to ensure that basic services are available to both refugees and host communities in urban and rural area. Finally, care for vulnerable cases in the rural area is also provided (through provision of NFIs, financial grants for income generating activities, etc).

A UN Volunteer receives a Volunteer Living Allowance (VLA) which is composed of the Monthly Living Allowance (MLA) and a Family Allowance (FA) for those with dependents (maximum three).

The Volunteer Living Allowance (VLA) is paid at the end of each month to cover housing, utilities, transportation, communications and other basic needs. The VLA can be computed by applying the Post-Adjustment Multiplier (PAM) to the VLA base rate of US\$ 1,602. The VLA base rate is a global rate across the world, while the PAM is duty station/country-specific and fluctuates on a monthly basis according to the cost of living. This method ensures that international UN Volunteers have comparable purchasing power at all duty stations irrespective of varying costs of living. The PAM is established by the International Civil Service Commission (ICSC) and is published at the beginning of every month on the ICSC website <a href="http://icsc.un.org">http://icsc.un.org</a>.

In non-family duty stations that belong to hardship categories D or E, as classified by the ICSC, international UN Volunteers receive a Well-Being Differential (WBD) on a monthly basis.

Furthermore, UN Volunteers are provided a settling-in-grant (SIG) at the start of the assignment (if the volunteer did not reside in the duty station for at least 6 months prior to taking up the assignment) and in the event of a permanent reassignment to another duty station.

UNV provides life, health, permanent disability insurances as well as assignment travel, annual leave, full integration in the UN security framework (including residential security reimbursements).

UN Volunteers are paid Daily Subsistence Allowance at the UN rate for official travels, flight tickets for periodic home visit and for the final repatriation travel (if applicable). Resettlement allowance is paid for satisfactory service at the end of the assignment.

UNV will provide, together with the offer of assignment, a copy of the Conditions of Service, including Code of conduct, to the successful candidate.
