Living Conditions

The UN Volunteer will reside in Jerusalem, which is a family duty station. It is currently at UNDSS security level MODERATE. As is the case for UN staff and partners, the volunteer will make his/her own arrangements for housing and transportation to and from work. International UN personnel rent furnished or unfurnished apartments found using agents or by word-of-mouth through colleagues. Personnel in Jerusalem and its vicinity usually use their own cars for transportation. Internationals who want to arrive or leave the country can either enter through Queen Alia International Airport in Amman, Jordan, and cross King Hussein/Allenby Bridge or Ben Gurion Airport in Tel Aviv, Israel. Travel into the West Bank is only permitted in a UN vehicle with a UN driver and no overnight stays are permitted except for at locations cleared by UNDSS. Travel into Gaza is only permitted in an armoured UN vehicle with a trained driver. Overnight stays in Gaza are strictly confined to an approved, secure hotel.

The UN volunteer will be based in Jerusalem and work in Jerusalem and the West Bank. The West Bank is currently at UNDSS security level MODERATE and the volunteer will be required to conduct regular field trips to refugee camps, urban areas and rural villages in the West Bank. The volunteer will be exposed to a community living in an insecure environment with a high level of poverty.

Jerusalem has a Mediterranean climate with hot, dry summers and short, wet, cool winters; temperature and rainfall vary depending on altitude and location. The Palestinian dialect is common to Egypt, Jordan, Lebanon, Syria and parts of Iraq. In Jerusalem, both English and Hebrew are also common. The Israeli shekel (NIS) is the currency of the occupied Palestinian territory and Israel. The time zone is GMT +2 hours.

The health care sector is divided into public and private health services. The public health service is accessible to all. Better health services can be found at private clinics and hospitals, which are spread out mainly in larger cities. Sophisticated medical care, including for children, is available throughout Jerusalem. Primary and secondary education is available for the children of international personnel in Jerusalem, which include schools such as the Anglican International School of Jerusalem and the Lycée Français de Jerusalem.

Organizational Context & Project Description

UNRWA is mandated to provide assistance and protection to some five million registered Palestine refugees. Its mission is to help Palestine refugees in Jordan, Lebanon, Syria, West Bank and the Gaza Strip to achieve their full potential in human development, pending a just solution to their plight. UNRWA's services encompass education, health care, relief and social services, camp infrastructure and improvement, microfinance and emergency assistance. UNRWA is funded almost entirely by voluntary contributions. UNRWA is the largest UN operation in the Middle East, with more than 30,000 staff. Most of these staff are refugees themselves, working directly to benefit their communities – as teachers, doctors, nurses or social workers.

UNRWA's Department of Legal Affairs (DLA) is based in Jerusalem and services all parts of UNRWA and areas of operations. Pursuant to its objective to provide "accurate, timely legal oversight and advice ... based on the Agency's regulatory framework and international law", as encapsulated in Output 16.1.2 under Outcome 16.1 of Strategic Objective 16 (Goal 5), DLA engages in the following activities:

Advise the Commissioner-General and senior-level advisory bodies established by the Commissioner-General, the Management Committee, UNRWA Departments and Field Offices;

Support the implementation of the Agency's reformed system for the Administration of Justice and represent the Agency in cases filed before the UNRWA Dispute Tribunal and appeals before the United Nations Administrative Tribunal;

Ensure consistent application and interpretation of Agency-wide legal instructions and policies, including on privileges and immunities, neutrality, detained staff, and attacks/threats against staff;

Advise HQ and Fields on contractual and commercial arrangements, procurement processes and activities, and financing/funding arrangements and the resolution of disputes relating thereto matters, the development of Agency standard contracts and the review of all non-standard contracts and donor agreements;

Advise relevant stakeholders on the administration of disciplinary measures, detained staff and other staffing issues in accordance with the regulatory framework;

Report to and liaise with governments, as appropriate, UN bodies, and NGOs on international law issues, including issues related to protection and development;

Review and draft Agency policies and procedures and documents;

Provide support and training to Fields and Headquarters.

During the assignment, the UN Volunteer would be interacting with many partners/organizations, in particular as part of the UN Volunteer's support for DLA's work on international law and protection issues with the UN and NGO community in the occupied Palestinian territory. Partners could include OHCHR, UNICEF, OCHA, Diakonia and other stakeholders within or outside the United Nations. These partners contribute to UNRWA's human development and protection work in a variety of ways. The UN Volunteer would also be expected to interact with many UNRWA departments across the HQ, Gaza and West Bank Field Offices and the other fields, including in relation to the Agency's protection function and general law matters.

Task description

Under the direct supervision of the Principal Legal Officer (International Law) or the Principal Legal Officer (General Law), the UN Volunteer will undertake the following tasks:

Provide specialist legal advice on the interpretation of international law, including human rights, international humanitarian law and UN privileges and immunities, and respond to requests from Headquarters and Fields;

Provide legal advice in support to the Agency's protection function and liaise with other UN Agencies and NGOs on protection issues, including through participating in UN working group meetings in the West Bank, as appropriate;

Draft and review reports to United Nations bodies, including the General Assembly and human rights mechanisms, to key donors and NGOs;

Assist in the development of human rights analysis, preparation of submissions to the international human rights system and advocacy in relation to the enjoyment of human rights of Palestine refugees;

Contribute specialist knowledge as a member of the legal team to large-scale legal research and policy development projects on issues engaging international law;

Assist in the provision of legal advice and assistance on matters arising from contracts entered into by the Agency, including those relating to procurement of goods and services and donor financing and project agreements for the delivery of humanitarian and development assistance;

Assist in research and analysis on a wide range of administrative law issues, including use of the Agency's system for internal administration of justice for staff members;

Provide legal input into Agency policies and strategies including to ensure compliance with international human rights standards:

Help build the capacity of colleagues in the Agency and, as appropriate, outside the Agency, through assisting in the development and delivery of training materials, coaching, mentoring and formal and on-the-job training, including in relation to international law training as appropriate;

Perform any other related duties as may be required.

Furthermore, UN Volunteers are required to:- Strengthen their knowledge and understanding of the concept of volunteerism by reading relevant UNV and external publications and take active part in UNV activities (for instance in events that mark International Volunteer Day)- Be acquainted with and build on traditional and/or local forms of volunteerism in the host country- Reflect on the type and quality of voluntary action that they are undertaking, including participation in ongoing reflection activities- Contribute articles/write-ups on field experiences and submit them for UNV publications/websites, newsletters, press releases, etc.- Assist with the UNV Buddy Programme for newly-arrived UN Volunteers- Promote or advise local groups in the use of online volunteering, or encourage relevant local individuals and organizations to use the UNV Online Volunteering service whenever technically possible.

A UN Volunteer receives a Volunteer Living Allowance (VLA) which is composed of the Monthly Living Allowance (MLA) and a Family Allowance (FA) for those with dependents (maximum three).

The Volunteer Living Allowance (VLA) is paid at the end of each month to cover housing, utilities, transportation, communications and other basic needs. The VLA can be computed by applying the Post-Adjustment Multiplier (PAM) to the VLA base rate of US\$ 1,602. The VLA base rate is a global rate across the world, while the PAM is duty station/country-specific and fluctuates on a monthly basis according to the cost of living. This method ensures that international UN Volunteers have comparable purchasing power at all duty stations irrespective of varying costs of living. The PAM is established by the International Civil Service Commission (ICSC) and is published at the beginning of every month on the ICSC website http://icsc.un.org.

In non-family duty stations that belong to hardship categories D or E, as classified by the ICSC, international UN Volunteers receive a Well-Being Differential (WBD) on a monthly basis.
