SUBJECT: Removal of the eligibility restriction for United Nations Volunteers

OBJET:

1. Following agreement with the Executive Coordinator of United Nations Volunteers Programme, I am pleased to announce the removal of the restriction on the eligibility of current and former United Nations Volunteers to be appointed for staff positions specified in section 6.12 of ST/AI/2010/3 on the staff selection system:

6.12 United Nations Volunteers may not be appointed to positions in the same mission in which they last served within six months following completion of their service with the United Nations Volunteer programme. United Nations Volunteers who have served less than 12 months are not eligible for appointment in a peacekeeping operation or special political mission, unless a period of six months has elapsed following completion of the United Nations Volunteer service. United Nations Volunteers who resign may not be appointed to a position in a peacekeeping operation or special political mission within six months following the date of resignation.

2. Effective immediately, current and former United Nations Volunteers may be considered for job openings based on their individual merits, irrespective of the duration of their service, the period that has elapsed from their last service, the location of the job opening or their previous resignation.
